**VOLUNTEERS** — We are delighted to report that David Baxter, FoSH Trustee, was voted Outstanding Volunteer of the Month in December 2023. This was in recognition of David's work on the Stamford Hospital Museum. David has spent years digitising archive documents dating back to the opening of the hospital, preserving objects collected from the cellars, cupboards and attics of the hospital and displaying these in cabinets in the hospital museum. Funding is available for a new and permanent home for the museum but finding a suitable space for this is proving troublesome. However, work will continue on this important topic.



**TRUST CHAIR** – In November, the committee met with Steve Barnett, together with Callum Gardner Medical Director, to answer questions we had regarding the value of Charities within the Trust and how we can support developments. It became clear from our discussions that Charities, such as FoSH, are still relevant and important contributors to the work of the Trust. Not only providing funding for items, large and small, but also as a link between our members (and any members of the public) and the Trust management to provide feedback and support for services and staff. **NEW TREATMENT CENTRE** – You may have seen in the Stamford Mercury plans for the proposed new Treatment Centre. This will be built on the site of the old nurses home and will replace the current day surgery unit/Dronfield suite located in what was Greenwood Ward. It will provide state of the art facilities for day case procedures. Subject to planning agreement, work on the new centre should commence later this year ready for opening in late 2025.
